Revision of Terms and Conditions of Employment for Support Staff for Ministers of Government, Parliamentary Secretaries

and certain other office holders

I wish to inform you that except in the case of the Motor Vehicle Facility, where applicable, the salary and other terms and conditions of employment applicable to the support staff of Ministers of Government, Parliamentary Secretaries and certain other office holders as indicated below, have been revised with effect from January 01, 2011. The revised Motor Vehicle Facility takes effect from the date of this Circular Memorandum.

(I) Personal support staff of Ministers of Government and Parliamentary Secretaries

#### **Cabinet Ministers**

- 1 Adviser
- 1 Personal Assistant
- 1 Personal Secretary

#### **Non-Cabinet Ministers**

- 1 Personal Assistant
- 1 Personal Secretary

#### Parliamentary Secretary

- 1 Personal Secretary
- (II) Senior Secretaries to Ministers of Government
- (III) Executive Assistants to Permanent Secretaries, the Chief Personnel Officer (CPO) and the Director of Personnel Administration (DPA)

In addition, except in the case of the Commuted Overtime, the terms and conditions of employment of Personal Chauffeurs of Cabinet and Non-Cabinet Ministers have also been revised with effect from **January 1**, **2011**. The revised Commuted Overtime took effect

from **July 1, 2010.** You are reminded that Personal Chauffeurs are the personal employees of each individual and **are not engaged on contract by the State.** As a consequence, **no contract** should be executed between the Permanent Secretary and such employee.

- 2. The revised salary and other terms and conditions applicable to the support staff identified above are set out at Appendices I to VI. However, where an Adviser, Personal Assistant or an Executive Assistant is employed for a period of less than one (1) year, the monthly Salary and Transport Allowance only set out in the relevant Appendices would be applicable, while in the case of the Personal Secretary, the monthly salary only set out in Appendix III would apply. In the case of the Personal Chauffeurs, the monthly salary, Commuted Overtime and allowances only would be payable.
- 3. You are reminded that the employment of the person selected as your Executive Assistant should be approved by your Minister, in accordance with the terms of Cabinet Minute No. 557 dated May 09, 2001. Also, since the Executive Assistant is intended to be personal to the Permanent Secretary/Head of Department, the contract should provide for him/her to continue in your employment for the period contracted notwithstanding that you may be assigned to another Ministry during such period and for the termination of employment of the individual when you cease to hold the office of Permanent Secretary/ Head of Department.
- 4. Should the person selected as an Executive Assistant hold an appointment to a pensionable office in the Public Service, Ministerial approval would need to be obtained for the grant to him/her of leave of absence without pay on grounds of public policy for the duration of the term of employment. In this event, you should observe, strictly, the provisions of PD Circular Memorandum PD(bm): 12/2/1 dated August 30, 2002 and note that since the grant of absence without pay on grounds of public policy enables the retention of the period of contract employment (while on such leave) as service that is reckonable for pension purposes, no contract gratuity would be applicable in such case.
- 5. Similarly, except in the case of Personal Chauffeurs who are the personal employees of Ministers, provision should be made in the contracts of employment of the persons employed as personal support staff listed at paragraph 1(I), for the termination of employment of such individuals when a Minister/Parliamentary Secretary demits office, that is, cease to be a Minister/Parliamentary Secretary.
- 6. I should appreciate it if you would take action to implement the revised terms and conditions of employment of the persons involved. Where necessary, you should consult with the Ministry of Finance and the Economy to identify the required funds.

## Terms and Conditions of Employment (on contract), applicable to the position of Adviser to a Cabinet Minister, with effect from January 01, 2011

Salary

\$19,400 per month

Vacation Leave (contract of one year's duration)

- (a) Subject to the Personal Leave clause below the person engaged shall be eligible for twenty (20) working days Vacation Leave.
- (b) The person engaged shall proceed on such leave after the eleventh (11<sup>th</sup>) month so as to terminate on the expiry date of the term of engagement.

Personal Leave (contract of one year's duration)

- (a) The person engaged may be granted Personal Leave up to five (5) working days during the twelve (12) month period of engagement to be taken at the mutual convenience of the parties.
- (b) Personal Leave granted shall be deducted from Vacation Leave.
