MEMORANDUM OF AGREEMENT

between

THE CHIEF PERSONNEL OFFICER

Party No. 1

and

THE PRISON OFFICERS'
ASSOCIATION OF TRINIDAD AND
TOBAGO (SECOND DIVISION)

Party No. 2

The Parties agree, following consultation and negotiation, to salaries being adjusted based on 85% of the market shift of 16.5%, which amounts to 14%. Also, the Parties agree to the undermentioned revised Terms and Conditions of Employment. The revised Salaries and Terms and Conditions of Employment shall apply with effect from the dates specified to full-time monthly-paid officers in the Second Division of the Trinidad and Tobago Prison Service.

SALARY

- (i) With effect from January 1, 2011, basic salary shall be adjusted to the rates as set out in Appendix I.
- (ii) The Cost of Living Allowance of \$145 per month which existed at December 31, 2010 shall be consolidated with the basic adjusted salaries referred to at (i) above.

5. TRANSFER BETWEEN TRINIDAD AND TOBAGO

A. (i) With effect from January 1, 2011, the allowance payable to an officer who is transferred from Trinidad to Tobago or vice versa, shall be as follows:-

(a) Transfer Allowance

With effect from January \$850 per month

1, 2011

With effect from January \$900 per month

1, 2012

With effect from January \$990 per month

1, 2013

(b) Housing Allowance (where housing/accommodation is not provided)

(i) where the transfer is from Tobago to Trinidad

With effect from January \$1,900 per month

1, 2011

With effect from January \$2,000 per month

1, 2013

(ii) where the transfer is from Trinidad to Tobago

With effect from January \$2,550 per month

1, 2011

With effect from January \$2,700 per month

1, 2013

- (ii) The conditions that govern the payment of these allowances as set out in the Memorandum of Agreement dated March 14, 2001 shall continue to apply and are reproduced hereunder:-
 - (a) The officer, whether married or single, shall be paid the Housing Allowance under this provision instead of the Housing Allowance at 4A. above;
 - (b) the allowances shall be payable for a maximum of eighteen (18) months which shall be the normal duration of a transfer;
 - (c) where, however, the officer is required to remain in the place of transfer beyond eighteen (18) months, because of the exigencies of the Service, payment of the allowances shall be extended accordingly;
 - (d) where, for personal reasons, the officer requests a transfer to or from Trinidad or Tobago or where, on being re-transferred, he/she requests his/her continued stay in Trinidad or Tobago, the allowances shall not be payable;
 - (e) where an officer is transferred on promotion to an office in Trinidad or Tobago, the allowances shall be payable for a maximum period of six (6) months;
 - (f) where the officer is promoted while on transfer, the allowances shall continue to be payable for a maximum period of six (6) months from the date of promotion, but not exceeding a total of eighteen (18) months from the date of transfer; and
 - (g) the allowances shall not be payable to an officer posted to Trinidad or to Tobago on first appointment: first appointment being his/her assignment for duty after completion of his/her period of initial training.

B. SPECIAL ALLOWANCE

With effect from January 1, 2011

(a) An officer living in Trinidad who, on completion of his/her initial period of training is assigned to duty in Tobago, shall, in addition to the House and Meal Allowances at 4A(i) and B(i) above be paid a Special Allowance for a maximum period of eighteen months as follows: With effect from January 1, 2011 \$850 per month

With effect from January 1, 2012 \$900 per month

With effect from January 1, 2013 \$990 per month

- (b) On the officer's return to Trinidad, he/she shall not be regarded as being on transfer and shall not qualify for the allowances at 5A above.
- (c) For purposes of (a) above, the officer shall be considered to be transferred when next he/she is required to take up official duty in Tobago.
- (d) The above arrangements shall apply mutatis mutandis to an officer living in Tobago who is assigned to Trinidad on completion on his/her initial period of training.

C. FAMILY VISITS

Three (3) airline tickets per quarter shall be prov. 'and to eligible officers. Alternatively, the officer may be provided with such number of tickets, by boat, which may be acquired at a cost not exceeding that of three (3) airline tickets.

The Commissioner of Prisons shall be responsible for approving the issue of tickets at c. above and effecting payment of the Transfer and Housing and Special Allowances referred to at A and B. above.

6. TRAVELLING FACILITIES AND ALLOWANCES

A. MOTOR VEHICLE UPKEEP ALLOWANCE

The **Upkeep Allowance** payable to the holder of an office included under Part I of the Third Schedule to the Travelling Allowances Regulations, Chapter 23:50, who is required to keep and use a motor vehicle in the performance of his/her official duties shall be as follows:-

With effect from January 1, 2011 \$2,200 per month

With effect from January 1, 2013 \$2,400 per month

B. ADVANCE TO PURCHASE A MOTOR VEHICLE

With effect from the date of issue of the relevant memorandum conveying instructions, the maximum amount to be advanced to an eligible officer for the purchase of a motor vehicle shall be \$160,000.

C. MOTOR VEHICLE REPAIR LOAN

The maximum amount to be advanced to an eligible officer for the purpose of effecting repairs to his/her motor vehicle shall be maintained at \$20,000.

D. KILOMETRIC ALLOWANCE

With effect from January 1, 2011, the Kilometric Allowance applicable to an officer who is required to keep and use a motor vehicle in the performance of his/her official duties shall be \$2.35 per kilometre.

E. KILOMETRIC ALLOWANCE UNDER REGULATION 16

With effect from January 1, 2011, the rate of the Kilometric Allowance payable under Regulation 16 of the Travelling Allowances Regulations shall be \$2.95 per kilometre.

F. SUBSISTENCE ALLOWANCE

(i) With effect from the date of issue of the relevant memorandum conveying instructions, and subject to the conditions set out in Regulation 43 of the Travelling Allowances Regulations being met, the Subsistence Allowance payable to an officer, who, in the course of his/her official duty, is required to travel beyond a radius of 16 kilometres (10 miles) from his/her station shall be as follows:-

IN TRINIDAD - \$150 per day

IN TOBAGO - \$162 per day

(ii) Where an officer qualifies for payment of Subsistence Allowance at (i) above, such proportion of the monthly Meal Allowance that would normally be payable to the officer in respect of the particular day shall be deducted from the Subsistence Allowance payable.

PERIOD OF AGREEMENT

The terms of this Agreement cover the period January 1, 2011 to December 31, 2013.

- (iii) The salaries referred to at (ii) above shall be adjusted further as follows:
 - (a) With effect from January 1, 2011 to December 31, 2011, the consolidated adjusted salaries at (ii) above plus twenty-nine percent (29%) of the difference between such salaries and the targeted quantum agreed upon by the Parties; derived from the application of 85% of the market shift, the shift being 16.5%.
 - (b) With effect from January 1, 2012 to December 31, 2012, the consolidated adjusted salaries at (ii) above plus fifty-seven percent (57%) of the difference between such salaries and the targeted quantum agreed upon by the Parties, derived from the application of 85% of the market shift, the shift being 16.5%.
 - With effect January 1, 2013 to December 31, 2013, the salaries representing the targeted quantum agreed upon by the Parties, derived from the application of 85% of the market shift, the shift being 16.5%.

The resultant salaries from (a) to (c) above are set out in Appendix II to this Agreement. .

2. LUMP SUM

A lump sum of \$4,000 shall be paid to each officer who held an appointment to Grades 1 to 3 in the Prison Service during the period January 01, 2011 to December 31, 2013.

Each officer shall be entitled to one lump sum only and such lump sum will be applicable to the substantive office which he/she held during the period. In the event that an officer was promoted to an office in the First Division during the period, the lump sum to be payable shall be that applicable to the office to which he/she was promoted.

3. COLA

A new COLA at the following rates shall be paid for the period January 1. 2011 to December 31, 2013:-

January 1, 2011 to December 31, 2011 \$160 per month

January 1, 2012 to December 31, 2012 \$175 per month

January 1, 2013 to December 31, 2013 \$225 per month

4. ALLOWANCES

A. HOUSE ALLOWANCE

(i) With effect from January 1, 2011, the monthly House Allowance payable to an entitled officer shall be as follows:-

Married Officer - \$1,425 per month

Single Officer - \$1,020 per month

- (ii) Where an officer is married to or marries another officer, each officer shall continue to be paid the House Allowance applicable to a single officer, save that where the allowance applicable to a married officer is greater than the total payable to the two officers at the single rate, the higher allowance shall be payable to one officer only.
- (iii) Where it is established to the satisfaction of the Commissioner of Prisons that a single officer who is in a common-law relationship meets the criteria set out in the Cohabitational Relationships Act, Chapter 45:55, the officer shall be paid the rate of House Allowance applicable to a married officer.

B. MEAL ALLOWANCE

- (i) With effect from January 1, 2011, the monthly Meal Allowance payable to an entitled officer shall be \$655 per month.
- (ii) An officer may also qualify for the provision of a meal or payment of a Meal Allowance in lieu thereof in the following circumstances:-
 - (a) where he/she is required and authorized to continue working for more than two hours beyond the end of his/her normal working shift of duty. As an example, an officer whose normal shift of duty is of twelve hours duration, would need to work beyond a total of fourteen hours in order to qualify for this benefit; and
 - (b) where the officer referred to at (a) above continues to work, as abovementioned, he/she would be eligible to be provided with another meal or the meal allowance in lieu thereof at the end of each

four hour period thereafter, calculated from two hours after the commencement of the period of excess hours.

With effect from April 15, 2015, the Meal Allowance applicable under this provision shall be at a rate equivalent to one-third of the daily Subsistence Allowance payable under the Travelling Allowances Regulations, that is to say:

IN TRINIDAD - \$50 per meal

IN TOBAGO - \$54 per meal

C. CARRERA DUTY ALLOWANCE

With effect from January 1, 2011, the Carrera Duty Allowance payable to an eligible officer shall be \$200 per month.

D. PLAIN CLOTHES ALLOWANCE

(i) WELFARE OFFICERS

With effect from January 1, 2011, the Plain Clothes Allowance payable to a Welfare Officer who is required to wear plain clothes in the performance of his/her duties shall be \$400 per month.

(ii) OFFICERS STATIONED AT THE YOUTH TRAINING CENTRE

With effect from January 1, 2011, the Plain Clothes Allowance payable to those officers stationed at the Youth Training Centre, who are required to wear plain clothes in the performance of their duties shall be \$160 per month.

(iii) PRISONS SUPERVISOR (INFIRMARY) AND PRISONS SUPERVISOR (WARRANTS)

With effect from January 1, 2011, the introduction of the Plain Clothes Allowance at the rate of \$325 per month payable to the Prisons Supervisor (Infirmary) and Prisons Supervisor (Warrants) who are required to wear plain clothes in the performance of their duties.

E. LAUNDRY ALLOWANCE

(i) With effect from January 1, 2011, the Laundry Allowance payable to officers/officers assigned to the areas identified hereunder shall be at the following rates:-



F. BILINGUAL ALLOWANCE

With effect from January 1, 2011, the Bilingual Allowance payable to an officer who is called upon to perform duties of interpreter/translator for inmates of the Prisons shall be \$195 per month.

G. SPECIAL PROJECT ALLOWANCE

(i) With effect from January 1, 2011, the Special Project Allowance payable to an eligible officer in the Construction Unit of the Prison Service who performs the under-mentioned functions shall be at the rates specified below:-

- (ii) The following conditions shall govern the payment of the allowance at (i) above:-
 - (a) The allowance shall be payable only during the period of construction.
 - (b) An officer shall not be paid additionally an Assimilation Allowance at H(i). below.
 - (c) The allowance shall not be paid during periods of vacation leave and extensions of sick leave.

H. ASSIMILATION ALLOWANCE

- (i) With effect from January 1, 2011, the Assimilation Allowance payable to the holders of those specialist positions listed in Appendix III pending the assimilation of the positions into the Grade Structure for the Prison Service shall be as set out therein.
- (ii) The payment of Assimilation Allowances in respect of the undermentioned offices shall cease from the dates identified:

Prisons Officer II (functioning as Officer-in- May 10, 2012 Charge, Tobago Prison)

Prisons Officer II (functioning as Officer-in- January 1, 2014 Charge, Personnel)

The Assimilation Allowance of \$575 per month payable to the Prison Officer II (Infirmary) shall be the subject of further discussion between the parties. In the interim, the current rate shall be maintained.

(iii) With effect from January 1, 2005, an Assimilation Allowance shall be payable to the undermentioned officers at the Maximum Security Prison:-

I. PROFICIENCY ALLOWANCE

(i) With effect from January 1, 2005, the Proficiency Allowances payable to the undermentioned officers at Maximum Security Prison shall be discontinued:-

Prisons Officer I (Systems Technician)

Prisons Officer I (Electrical Technician)

- (ii) With effect from August 1, 2015, the Proficiency Allowances payable to officers at the Maximum Security Prison excluding Prisons Officer I (Beautification/Maintenance), Prisons Officer I (Wastewater, Plant Operator/Technician) shall be discontinued.
- (iii) With effect from January 1, 2011, Proficiency Allowance payable to officers who possess specified skills and perform the under-mentioned duties, shall be increased to the rates specified below:-

(iv) With effect from January 1, 2011, the Proficiency Allowance payable to the officer(s) performing the duties of Locksmith shall be \$330 per month.

J. QUALIFICATION ALLOWANCE

(i) With effect from January 1, 2011, the Qualification Allowance payable to an officer who possesses a recognized Degree in one of the undermentioned disciplines shall be at the rates specified below:-

MCSE (Microsoft Certified Systems Engineer)

- (ii) With effect from January 1, 2011, the Qualification Allowance payable to an officer who possesses the Legal Education Certificate (LEC) or equivalent shall be \$1,150 per month.
- (iii) With effect from January 1, 2011, the Qualification Allowance payable to an officer holding a recognized Degree in Occupational Safety and Health (OSH) or a National Examination Board in Occupational Safety and Health (NEBOSH) Diploma shall be \$1,045 per month.
- (iv) With effect from January 1, 2011, the Qualification Allowance payable to an officer who possesses the Bachelor of Law Degree (LLB) shall be \$1,045 per month.

In order to qualify for the payment of a Qualification Allowance at (i) to (iv) above, an officer shall be required by the Commissioner of Prisons to utilize the skill on an **on-going** basis in the performance of his/her official duties.

K. PRACTICE TEACHER ALLOWANCE

With effect from January 1, 2011, the Practice Teacher Allowance shall be \$420 per month. The allowance shall be payable to a Prisons Welfare Officer II/Prisons Welfare Officer I who, on the request of the Commissioner of Prisons, is assigned by the Chief Prisons Welfare Officer to supervise students who are on attachment to the Prison Service.
